### TERMS AND CONDITIONS

This is an Application and Agreement for credit and shall apply to any credit extended by COMPLETE SHIPPING SOLUTIONS. The credit applicant understands and agrees to the following terms and conditions of sale:

1. Terms of sale are net 30 days from ship date for **Complete Shipping Solutions** and 15 days for **Complete Express**.
  1. A) Interest will be charged at the rate of 2% per month (26.82% per annum) on overdue accounts commencing on the 1<sup>st</sup> day that the applicants account is overdue.
  
2. Copies of lost or misplaced invoices provided to the applicant may be subject to a \$20.00 charge.
  
3. NSF cheques will be subject to a \$50.00 charge.
  
4. Failure to comply with these Terms and Conditions may result in cancellation of credit privileges without notice. In the event of any default, COMPLETE SHIPPING SOLUTIONS may:
  - (a) Close the account and/or
  - (b) Accelerate payment of the full balance
  
5. Applicant agrees to bear all costs incurred in collecting any unpaid amounts but not limited to collection suit fees, legal fees and court costs.
  
6. The information given in this Application and Agreement is warranted to be true and correct and given for obtaining credit.
  
7. The Applicant consents to the obtaining of credit and/or personal information as may be required in connection with the credit line hereby applied for or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit

reporting agency or to any person with whom the applicant has or proposes to have financial relations.

8. Upon determination that a customer's creditworthiness has changed adversely or does not satisfy current credit standards, **COMPLETE SHIPPING SOLUTIONS** may close or lower the credit limit of the account.
9. The applicant or applicants hereby agree that where there is more than one party to this agreement they shall be jointly and severally liable in the event of default hereunder.
10. The Owner is obligated to notify COMPLETE SHIPPING SOLUTIONS in writing of any changes in ownership.
11. The applicant grants to COMPLETE SHIPPING SOLUTIONS a security interest in all personal property stored or left in COMPLETE SHIPPING SOLUTIONS possession until such time that all amounts owing by the applicant to COMPLETE SHIPPING SOLUTIONS are paid.
